1. Tax assesment and tax account statement of the last verified tax year from every person over 18-years old

In case taxing information states any of the applicant owning a real estate (apartment, summer house) a declaration of its current value is needed.
If the applicant has sold the estate, a copy of sales contract and proof of the paid debt must be presented.

2. Declaration on monthly income

- Latest paycheck, proof on paid unemployment benefits
- Proof of paid benefits, e.g social assistance
- School certificate from over 18-old students
- Verdict on paid pension
- Financial statement from entrepreneurs

3. Proof of pregnancy that states the expected date of birth.
